In the reference 1<sup>st</sup> cited the Government of Andhra Pradesh has declared that a complete lockdown of Andhra Pradesh State has to be observed to prevent onset of community transmission of the Corona-virus in the State till 31<sup>st</sup> March, 2020. As per the guidelines, no transport vehicles, including inter-state transport services, shall be permitted, except the vehicles carrying essential commodities.

In the reference 2<sup>nd</sup> cited, keeping in view of spread of COVID-19 epidemic in the Country, the Government of India has Lockdown throughout the Country and issued certain guidelines to be followed in the Country for a period of 21 days w.e.f. 25-03-2020 i.e., upto 14-04-2020. As per the guidelines all the State Government Offices shall be closed, except certain essential services departments. As per guideline (6), all transport services - air, rail, roadways - will remain suspended, except transportation for essential goods only and fire, law and order and emergency services.

Therefore, there is no scope for plying of transport vehicles till 14<sup>th</sup> April, 2020. It came to notice that the registered owners of transport vehicles intend to file stoppage of their vehicles applications in the offices. Since the offices are not functioning, it is decided to allow the registered owners of the transport vehicles to file stoppage of their applications through mail or WhatsApp.

A proforma of application for filing of stoppage of vehicles is appended. The registered owners are permitted to file applications for stoppage of their vehicles on or before 31-03-2020 through email or WhatsApp numbers given in the Annexure. The Secretary, Regional Transport Authorities of the concerned Districts are requested to accept the applications submitted through email or WhatsApp and an acknowledgement shall be sent to the registered owner through mail or WhatsApp. The registered owners are directed to submit the original RC, Permit, IC etc., documents within one week from the closure of Lockdown.

All the Deputy Transport Commissioners are requested to give wide publicity among the registered owners of the transport vehicles.
